

Full Arch Box Stock Agreement

PREAMBLE

This Full Arch Box Stock Agreement is an addendum to the "General Supply Agreement for the purchasing of production material" and to the "Delivery Regulation for Order Processing" between the Purchaser and the Supplier in order to establish and maintain a Full Arch Box stock.

- **1 Full Arch Box Stock**

a. The Supplier has set up a Full Arch Box stock for the products listed on Appendix A.

- **2 Inventory Level**

a. The minimum Full Arch Box stock level has the function of a buffer stock and has to be provided by the supplier.

b. Both parties mutually agree on a minimum Full Arch Box stock level listed in Appendix A.

c. If the stock quantities fall below the minimum Full Arch Box stock level, the Supplier is engaged to replenish the minimum stock level using the Full Arch Box stock sheets provided.

- **3 Ownership of the Full Arch Box Stock**

The goods stored in the Full Arch Box stock shall be the property of the Supplier. Ownership and risk shall pass to the Purchaser when goods are withdrawn from the Full Arch Box stock.

- **4 Warranty**

The warranty period for products shall commence upon the withdrawal of products from the Full Arch Box stock by the Purchaser. Warranty liabilities shall in all other respects comply with the "General Supply Agreement for the purchasing of production material"

- **5 Inventory Management**

a. The Purchaser has to insure the Full Arch Box products on its own cost.

b. The Purchaser will without delay notify the Supplier in writing of any defects detected in parts withdrawn by the Purchaser when they are detected in the normal course of business. The incoming goods inspection at the Purchaser is limited to quantity verification, visual inspection of the packaging for visible damage such as damage in transit and an identity check by means of comparison of the shipping documents with the order documents.

- **6 Reporting**

The Purchaser will provide the report of the products used from the Full Arch Box stock (see appendix A). The report shall include the product part and lot numbers. The Supplier charges the products taken by the Customer as reported by the Purchaser using the full arch stock level sheet.

- **7 Removal of Products from the Full Arch Box Stock**

a. The Purchaser shall be entitled to withdraw goods from the Full Arch Box stock based on their requirements. The relevant prices agreed between the parties on the date of withdrawal shall apply.

b. The Purchaser shall consider the first-in-first-out principle (FIFO).

- **8 Term of Agreement and Termination**

The Agreement will come into effect upon delivery of the Full Arch Box by your Territory Manager on the pre-arranged date agreed on page 1 and will end upon collection of the Full Arch Box by you Territory Manager.

- **9 Amendments and additions**

No amendments or additions to this contract shall be valid unless made in writing.
